We will also test to ensure that pages will display visually in a similar — not necessarily an identical — way in Microsoft Internet Explorer 7 for Windows as this browser is now past its sell-by date.

NOTE: We will not test these templates in old or abandoned browsers, for example, Microsoft Internet Explorer 5, 5.5, or 6 for Windows or Mac, previous versions of Apple's Safari, Mozilla Firefox, or Opera unless otherwise specified.

Text / Copy / Content

We are not responsible for writing or inputting any text copy. We will be happy to help input major headings and content for optimal SEO, but significant work on our part will result in a charge beyond the original price.

We will guide you with the design so you know how to plan your copy, but you will be in charge of your own voice and content.

Photographs
